Status of the Industry: Unequal Information



The Producing End:

- 1. Herding effect
- 2. No effective production plan
- 3. Poor ability to resist risks
- 4. Low Input-output ratio

□ The Circulation End:

- 1. Dependent on the weather
- 2. Speculation, hoarding goods, malicious speculation, etc.
- 3. Increase the cost of the entire industry
- 4. Income fluctuations, sudden wealth co-exists with re-poverty.


□ The Enterprise End:

- 1. Single channel
- 2. Unclear resources, no quality guarantee.
- 3. Withstand malicious speculation and increased raw material costs
- 4. Unstable supply



1. Status of the industry - the high cost and adulteration






- up to 8-12 Intermediate links had artificially increased the cost of authentic Chinese herbal medicines in circulation.
- uneven quality of the dealers

1. Industry Dilemma - high distribution costs



□ The place of origin for Chinese herbal medicine is located all over China, resulting in difficult distribution and costly procurement.





1. Industry Dilemma - high threshold of raw materials



- Difficulty in buying, selling, goods inspecting, collecting and storing, while easy to dispute
 - 1. The commonly used Chinese herbal medicines achieve up to 679 (excluding differences in specifications)
 - 2. Places of origin of scale: 1872
 - 3. Lack of inspection and delivery agencies as well as After preparation process
 - 4. Collection difficulties as recurring industry illness
 - 5. Some herbs fail because of no professional storage nor disposal facility
 - 6. Goods of Raw Materials involves more disputes, while no corresponding mediation and supervision takes effect.






