

THE NETWORK SPEAKS

Working Together to improve public service delivery

The <u>MENA Network of Public Procurement Experts</u> represents a landmark achievement in the regional effort to help countries assist one another in strengthening their public procurement systems. Established in June 2013, the Network is composed of government-nominated representatives, responsible for leading public procurement in nine MENA countries – Djibouti, Egypt, Jordan, Lebanon, Libya, Morocco, Palestinian Territories, Tunisia, and Yemen. The World Bank's MENA Procurement Team has been critical to the birth and development of this initiative, under the leadership of Regional Procurement Manager Yolanda Tayler and the guidance of Director of Strategy and Operations Gerard Byam.

The Network has endorsed three priority areas for regional collaboration: the development of capacity in the procurement workforce; the modernization of procurement tools; and, the improvement of business opportunities for small and medium enterprises (SMEs) in public procurement. The goals and objectives of each activity, along with important benefits that will be brought to the region through their implementation, are articulated below by representatives of the Network countries leading these efforts.



Mr. Abdellatif Jari is a representative of the Government of Morocco, which is leading the Subcommittee on the Modernization of

Procurement Tools. He is the Head of the Department of e-Procurement System in the General Treasury of the Kingdom of Morocco.



Mr. Tarek El-Salem, a member of the Procurement Capacity Building Initiative, is the Senior Training Manager at the Arab Administrative

Development Organization (ARADO) of the Arab League. He is based in Cairo, Egypt.



Mr. Karim Chabir is the Deputy Chief in the Tunisian High Tender Board. He is a representative of the Government of Tunisia which is leading the new

Network Subcommittee on Creating Business Opportunities for SMEs in Public Procurement.



Mr. Jean Ellieh (left), is the Director General of the Central Tender Board of Lebanon. He is joined in representing Lebanon in the Network by Judge Elie Maalouf (right) of the Court of Accounts in Lebanon. The Government of Lebanon is serving as the interim Network Secretariat.



Why is the work of your sub-committee needed for the Network, for the region and for your country? What direct and indirect benefits do you believe your subcommittees' work will provide to these groups? What existing challenges will this work address?

"The workshop in Tunis was a great chance to tackle an important, oftenneglected issue that most MENA region countries suffer from - the lack of a unified practice in the field of public procurement and the urgent need for capacity building. The impact of the capacity building subcommittee is both direct and indirect. It is direct in that it will create a training program in the field of Public procurement that will enhance the procurement workforce's knowledge about best practices. It will also introduce Training-of-Trainer programs to create a pool of trainers in the MENA region countries that will ensure the continuity of flow of training in the region. The subcommittee will have the indirect impact of enriching the field of Public procurement, and making it an attractive profession for talented people in both the public and private sector. "

"The work of the **SME subcommittee** is important for the Network in the sense that this subcommittee will act as a primary point of contact between procurement professionals in the MENA region and the private sector. This work will be very beneficial for the region in that it will promote a more participatory and more concerted action-oriented approach towards dialogue between the private and public sectors, rather than a one-sided conversation. In the case of our country of Tunisia, dialogue with SMEs and mentoring to increase their participation in government contracting will strengthen the development and quality orientation of SMEs, which represent a substantial percentage of the country's economy. The actions of our subcommittee therefore are very important: better-fit procedures for the award and implementation of government contracts, remedies and administrative shortcuts that will help SMEs to control costs, optimize their recruitment and to better identify the opportunities and contracts that are most compatible with their abilities."

"The implementation of regional public procurement platform is an ambitious project with a regional dimension.
