- E-Procurement System has been successfully launched. By 2016, all biddings will be conducted via the system over the country.
- Government Procurement Agency was established regarding the amendment of PPLM in 2012.
- Ministry of Finance shall not review proposals and contracting shall provide procuring entities with policies, guidelines and supervision activities regarding the procurement matters.



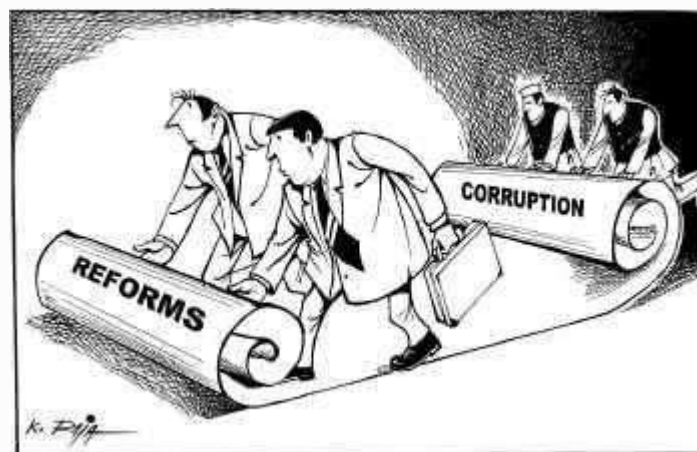


BACKGROUND

- Biddings are now available to announce as soon as state budget approved by Parliament.
- Citizens and community are allowed to be members of evaluation committee for the purpose of public awareness and transparency.
- Professional procurement units were established in the local level.





BACKGROUND

- The tendering shall be carried out and completed within 45 days since its opening and a tender shall be valid during this period. This period will be extended by 30 days once.
- Members of the evaluation committee shall be specialized in procurement.
- At least 2 delegations from NGO or bidders and citizens in evaluation committee





BACKGROUND

- Procuring entity shall select one or more suppliers, service providers or contractors on provision of regular use goods, works and services based on agreed price and other terms and conditions for the duration of up to 3 years.-Framework Agreement.
- Ministry of Finance reviews complaints after award the contracts.





BACKGROUND



Procurement Inspector

Ministry of Finance is responsible for blacklisting. Inspectors shall have the following powers.

- make an official statement on release of public officers who were involved in violations.
- annul an invalid contract.
- annul contracts that transferred contract obligations to a third party without approval of procuring entity made payments that exceed the amount previously stated in the bidding documents.

Establishment of electronic procurement legal environment.

- E-Shopping,

FURTHER ASPECTS



Ministry of Finance will continually support GPA and will amend and make clear GPA's duties and responsibilities in PPLM.

The list of national and regional projects and activities to be undertaken by the procurement professional organization shall be included:

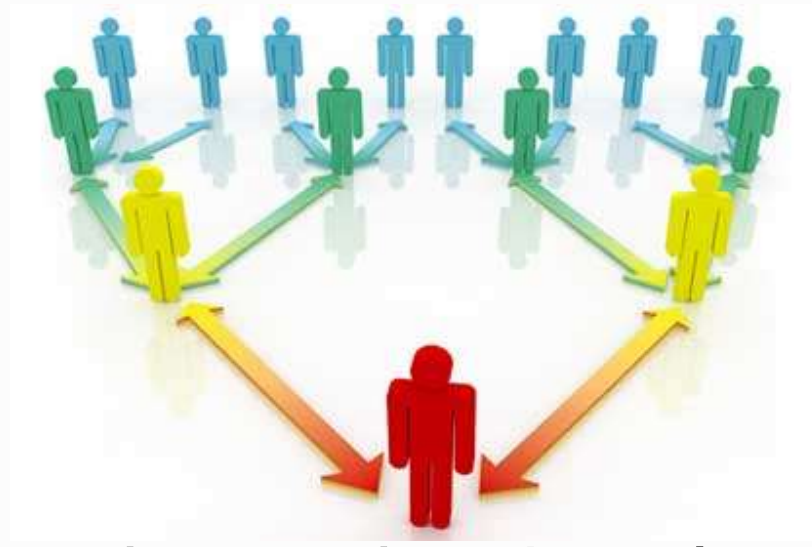
- Projects are financed by State Budget Law;
- Projects are financed by foreign aid and loans.

- Continuing to harmonize donor's guidelines with domestic legislations.
- To develop a better dispute mechanism.
- To expedite bidding duration as much as possible.



FURTHER ASPECTS



МОНГОЛ УЛСЫН
ЗАСГИЙН ГАЗАР

In connection with expedition of bidding duration of projects funded by foreign loan and aid, the following actions are needed to be taken:

- Advanced procurement procedure will be introduced on condition that it is approved by the Donor;
- Detailed procurement plan will be legislated;
- Consulting service for small size will be simplified.





FURTHER ASPECTS



Procurement training centers will be established in provinces in order to:

- train procurement training teachers,
- build capacity in the local level,
- monitor and audit the implementation of projects funded by state budget and local development fund.
