



**World Bank Group Strategy for Fragility, Conflict and Violence (FCV)
Consultation Meeting with Civil Society and
World Bank-financed Projects**

Feedback Summary

Date: 05/20/2019, 9h00-11h30

Location: N'Djamena, Chad

Audience: Civil society organizations and World Bank-financed projects

Overview and Key Issues Discussed: Ziva Razafintsalama (Senior Agriculture Specialist, Chad) and Olivier Lavinal (Senior Operations Officer, FCV Group) welcomed the participants present in N'Djamena. They presented the FCV strategy concept. Participants were then invited to ask questions and to express their views. The following summary highlights comments that were provided by stakeholders and notes general themes across the discussion.

Specific Feedback from Stakeholders
1. Overall
Participants expressed their support for the WBG's willingness to engage in FCV situations, noting the need to adapt to the country challenges and underlying the importance of governance. They highlighted the importance of the role of the World Bank Group (WBG) in supporting the government but also in enabling private sector development. They were supportive of the proposed four areas of engagement proposed in the Concept Note.
2. Theme: Priority areas
Participants highlighted the following priority areas of engagement: <ul style="list-style-type: none">• Enabling private sector growth, with special focus on SMEs and women economic empowerment• Promotion of good governance• Increasing access to basic social services, with special focus on education and health• Call for multi-sector operations, with special focus on water-energy-food nexus• Better management of natural resources• Supporting women's empowerment

Specific Feedback from Stakeholders
3. Theme: Governance
Participants insisted on the importance of good governance. They articulated that the approach to addressing needs to be preventive, by building the legitimacy of the state and allowing for freedom of expression thereby creating better social cohesion. They raised the challenges of corruption, the need for well-functioning institutions both at national and local levels, as well as well-trained personnel in the justice system. In these efforts on good governance, participants mentioned the importance of working with civil society actors.
4. Theme: Managing access to natural resources and services
Participants outlined the importance of addressing the growing tensions over the access to natural resources – such as land and water – as well as access to services – such as energy and social services. One indicator of these tensions is the increase in both agro-pastoral conflicts and conflicts between pastoral groups are increasing. The pressure on limited resources and services is being further exacerbated by climate change induced changes in migration patterns and the presence of forcibly displaced in the same areas. Participants insisted on the need to take into account the linkages between the different types of fragility.
5. Theme: Private sector support and its preconditions
Participants emphasized the primacy of enabling private sector growth for job creation. They highlighted the direct link between youth unemployment and increased migration. In order to support the private sector, participants mentioned different solutions such as: i) access to financing for small and medium enterprises; ii) availability of qualified and healthy staff covered by insurance; iii) access to energy and connectivity through transport infrastructure. Participants called for enhanced support in this sector, also to strike a balance between public and private interventions.
6. Theme: Better management of refugee situations
Participants discussed the role of development actors in engaging in forced displacement situations, from the beginning of a crisis to a medium- to long-term intervention. They called for increased attention on this subject as it is an additional challenge in a country that is already confronted with many development challenges. In addition, several participants highlighted the need to also focus on migrants and migration routes. This challenge cuts across the entire Africa region and impacts populations at large.
