# **Distinguished Ladies and Gentlemen**

It is my pleasure to welcome you to the launch of the Ghana Urbanization Review (GUR) Report. The Review was jointly undertaken by the Ministry of Local Government and Rural Development and the World Bank with support from the Swiss State Secretariat for Economic Development (SECO). The Review is meant to provide Government with additional data to evaluate the implementation of the Ghana National Urban Policy which seeks to provide a more comfortable environment for our urbanized population.

#### Mr. Chairman

I wish to recall earlier projects such as the Village Infrastructure Project (VIP), Community-Based Rural Development Project (CBRDP), Urban I–V Project and the Urban Environmental Sanitation Project among others which were implemented with support from the World Bank. These earlier Projects contributed to the socio-economic transformation of Ghana. I am particularly excited about the Report because it provides recommendations for managing and integrating Metropolitan, Municipal and District Assemblies (MMDAs) through improved service delivery and by providing legal and financial backing for speedy economic development of MMDAs.

Secondly, the Report deals with the crucial issues of Municipal Financing for urban infrastructure development through this, it is possible to wean off well-endowed Metropolitan and Municipal Assemblies from Central Government Transfers, since some of them have the capacity to be financially autonomous and can generate adequate resources to invest in capital projects that would make their cities more productive, inclusive and resilient.

### Mr. Chairman

It is my hope that after the launch of this Report, we should be able to deal more meaningfully with the challenge of integrated land use planning for effective urban development, provide strategic infrastructure development and regulate the transport sector for effective urban mobility and consolidate the gains made over the last 20 years of decentralization by also deepening fiscal decentralization and exploring more innovative ways for financing urban development.
