REGIONAL PUBLIC PROCUREMENT FORUM TASHKENT, APRIL 25-28, 2005

The first ever Central Asia Regional Public Procurement Forum was held in Tashkent, Uzbekistan from April 25 to 28. The Forum was sponsored by the World Bank. The heads of public procurement in Kazakhstan, Kyrgyzstan, and Tajikistan attended the Forum. Several participants from Uzbekistan took part in the Forum. ADB, EU, Islamic Development Bank, International Trade Center, UNDP, and USAID were also represented. (See the attached list of participants).

The main objectives of the Forum were to bring together the public procurement officials of the four countries to foster regional cooperation and to provide them with a platform to exchange their knowledge and experiences over public procurement reforms. These objectives have been successfully achieved.

From the presentations made by the four delegations, the participants learned about the status of development of their procurement systems, the areas that needed attention and their solutions. Kazakhstan has made continuous efforts to improve its system and is now in an advanced stage of e-procurement introduction; the Kyrgyz Republic has also been improving its public procurement law and is making efforts to organize itself for an effective implementation of the law. Tajikistan has just prepared a draft comprehensive public procurement law; while Uzbekistan has several resolutions which regulate public procurement.

The Forum provided an excellent opportunity for the donor representatives also to learn about the public procurement systems in the four countries. They informed the participants about the their support to public procurement, and their intention to improve these systems which can bring substantial gains to the country's economy and also to bring them up to an acceptable level where the country may be able to use its own system for the projects financed by them rather than continuing with the present arrangement of "ring fenced" projects and application of respective donor procedures.

Ms. Francoise Bentchikou and Mr. Walser from the World Bank informed the participants of the latest developments in the area of procurement regulatory framework both at the international and national levels. They also discussed the issues that are generally found in the pieces of procurement legislation in different countries and affect the economy and efficiency aspects of public procurement. Ms. Bentchikou held training sessions in identifying and preventing corruption and in evaluation of bids; Mr. Bhattacharya in preparing technical specifications that promote transparent procurement process.

The highlight of the Forum was the break-out sessions. The participants broke into three groups. The groups in breakout sessions considered the following topics:

a. Regional cooperation and integration in the medium and long-term;

- b. Identification of best practices the implementation of which will ensure the establishment of a sound public procurement system; and
- c. Donors' support to Central Asian Countries in Establishing and Implementing Sound Public Procurement Systems.

The groups identified best practices from each country. It is expected that the authorized body in each country will ensure that these practices are followed.

The groups also discussed the needs of each of the four countries for improving their public procurement systems. For example, the main recommendations are for the government to designate an organization to lead the public procurement reform and eventually to improve the legislation through consolidation of resolutions.

Continuous improvement in the public procurement regulatory framework and the need for training a large number of public procurement officials were identified as common issues in all the countries.

The participants learned about the status of e-procurement in Kazakhstan, and the prerequisites of e-procurement. Kazakhstan being in an advanced stage of introduction of e-procurement can serve as a model and resource for the other countries that also intend to introduce e-procurement as well. The participants learned that the main advantages of e-procurement are speed and improved transparency. The Kazakhstan delegation offered to help the other countries in this respect.

While Kazakhstan needs technical assistance in e-procurement, all other countries are at an inception stage of e-procurement and also need support.

Kyrgyzstan and Tajikistan also need assistance in effectively implementing their public procurement laws, including preparation of implementation regulations, manuals, standard bidding documents, etc.

The conclusions of the three groups are included in the attachment below. The groups made, among others, the following recommendations:

- Establish a regional public procurement group to ensure regular contact and dialogue for exchange of experiences;
- o Organize this Forum on an annual basis. The participants agreed that the next Forum will be organized in Kazakhstan in early June 2006;
- Introduce trial regional bidding using national regulations. This will not only expand competition but will promote regional integration and cooperation; and

o In the long-term, strive for making the public procurement regulatory framework of the four countries essentially identical.

The donor representatives (World Bank, Asian Development Bank, Islamic Development Bank, USAID, etc) appreciated the need to support through technical and financial assistance the public procurement systems in the country. Following Governments requests, they will be willing to consider the needs identified by the Forum and will explore ways and means of fulfilling these.

For Uzbekistan, Kyrgyzstan and Tajikistan, the Government(s) would wish to proceed with the actions recommended by the Forum and would need resources, Donor community should consider mobilizing support and grant funds.

Next Steps:

The participants unanimously agreed on the following next steps:

- a. Each country will nominate two senior public procurement officials, including, preferably, the head of public procurement in each country, to the Regional Public Procurement Group. The terms of reference of the Group will be to: (a) assure regular contact among the authorized bodies of the four countries to keep abreast of the developments in the public procurement system of their respective countries; (b) to organize regional learning events for senior public procurement officials to improve their knowledge and skills in ensuring effective functioning of their public procurement systems; (c) to exchange their staff for on-the-job training; (d) to continuously explore ways and means for strengthening regional cooperation in the field of public procurement, including regional open tendering; and (e) to oversee the implementation of the recommendations of the Tashkent Forum and those of future forums. Until the Regional Group is established and becomes operational, Naushad Khan will serve, on behalf of the World Bank, as the coordinator of the Regional Public Procurement Group.
- b. Organize the next Regional Public Procurement Forum in Kazakhstan in early June 2006 (location to be decided upon by the Kazakh Government).
