

PRIVACY NOTICE

The World Bank Group (including the International Bank for Reconstruction and Development (IBRD), the International Development Association (IDA), the International Finance Corporation (IFC), and the Multilateral Investment Guarantee Agency (MIGA)), the Inter-American Development Bank Group, and the George Washington University Law School (collectively, the “Organizing Institutions,” “we,” or “us”) are providing this Privacy Notice to be transparent about how your personal data will be processed. The Organizing Institutions are committed to protecting your personal data by establishing and complying with the following Privacy Notice which adheres to the core privacy principles set forth in the Organizing Institutions’ relevant data privacy policies. Each of the Organizing Institutions will act as independent controllers and be responsible for their own processing of personal data. This Privacy Notice applies to the personal data each of the Organizing Institutions collects and handles for the purposes of (i) registering for, and participating in its events; and (ii) engaging with its activities, including accessing links to third-party websites and web applications associated with the delivery of Organizing Institutions’ activities, such as event registration services, event attendance services, and event related promotional or publicity purposes. For the purposes of this Privacy Notice, “personal data” means any information relating to an identified or identifiable individual.

INFORMATION WE COLLECT

Information You Provide to the Organizing Institutions

The Organizing Institutions collect personal data from you directly, including the information you enter during registration or participation in our events, and photographic, audio and video footage that may be collected during the relevant events.

INFORMATION WE SHARE

The Organizing Institutions do not sell or otherwise disclose personal data collected, except as described in this Privacy Notice. Information may be shared with third-party service providers who perform services for the Organizing Institutions (i.e., registration or virtual event hosting, event management vendors, hotels, various transportation companies, and travel agencies). The Organizing Institutions require its service providers to appropriately safeguard the privacy and security of personal data they process on its behalf.

Third parties refer to any other party that is not part of the Organizing Institutions. Therefore, the consent provided in this form extends to all Organizing Institutions as the legal entities conducting this data collection and handling for the purposes stated in this notice.

We may share links to third-party sites and applications. Our provision of any of these is for your convenience and does not signify our endorsement of such sites or applications or their contents. We do not control sites, applications or other services operated by third parties and we are not responsible for their data protection and privacy practices, so we recommend that you review their privacy policies and practices.

We also may disclose Personal Data about you (i) if obliged to do so under international law (when applicable) or by requirements of applicable policies and procedures of the Organizing Institutions, (ii) for the purposes of, or in connection with, any legal proceedings, or otherwise for the purposes of establishing, exercising or defending any legal right; (iii) if it is in your vital or best interest, or in the vital or best interest of another person, or (iv) when we believe disclosure is necessary or appropriate to prevent physical harm or financial loss or in connection with an investigation of suspected or actual illegal activity.

PURPOSES AND TYPES OF PROCESSING

In providing excellent knowledge-sharing experience to you and supporting administrative tasks, the Organizing Institutions, and third parties working with us may process your personal data in the following ways:

To create and manage your personal account for the event you registered for;

- To send you email notifications and updates about the event you registered for;
- To send you a formal invitation letter, if applicable;

To provide you with agendas, knowledge resources (e.g. knowledge products, video links), and other administrative documents related to our events.

- To provide technical support to you before and during an event;
To make travel arrangement and other logistical arrangement, if applicable and with your consent;
- To award you with the certificate of completion and other event-related prizes, if applicable;
To contact you occasionally to invite you to share your opinions and experiences with regard to our events;
To connect you with technical experts and provide technical assistance in the form of operational support or other technical assistance activity;
To use your information in an aggregated format and anonymous format to evaluate and improve our events and activities;
To contact you occasionally to invite you to join our future events (with your consent);
- To publish participants' opinions and experiences on our website, our SNS accounts (i.e. Facebook, Twitter, and LinkedIn), our Annual Reports, our newsletters, World Bank Feature Stories, World Bank blogs, and other World Bank reports and IDB publicity and promotional materials; or
- To publish event-related photos and videos on our website, our SNS accounts (i.e. Facebook, Twitter, and LinkedIn), our Annual Reports, our newsletters, World Bank Feature Stories, World Bank blogs, and other World Bank reports and IDB publicity and promotional materials.

HOW WE PROTECT YOUR INFORMATION

We maintain appropriate technical and organizational safeguards against unauthorized processing of personal data and against accidental loss, destruction, or damage according to the applicable information security standards of the Organizing Institutions.

HOW LONG WE KEEP YOUR INFORMATION

Your Personal Data will be kept only as long as necessary for the purposes set out in this Privacy Notice and in accordance with applicable records retention and disposition schedules of each of the Affiliate Institutions.

REQUEST AND REVIEW
